

End User License Agreement

End User License Agreement This End User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Watchtower Security, INC. ("Watchtower Security") with regard to the copyrighted Software (herein referred to as "SOFTWARE PRODUCT" or "SOFTWARE") provided with this EULA.

The SOFTWARE PRODUCT includes computer software, the associated media, any printed materials, and any "online" or electronic documentation. Use of any software and related documentation ("Software") provided to you by Watchtower Security in whatever form or media, will constitute your acceptance of these terms, unless separate terms are provided by the software supplier, in which case certain additional or different terms may apply.

If you do not agree with the terms of this EULA, do not download, install, copy or use the Software. By installing, copying or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, Watchtower Security is unwilling to license the SOFTWARE PRODUCT to you.
